## End-User License Agreement (EULA)

Our EULA was last updated on 05/24/2023.

Please read this End-User License Agreement carefully before clicking the "I Agree" button, downloading or using the Singulator Software.

### Definitions

For the purposes of this End-User License Agreement:

- **"Agreement"** means this End-User License Agreement that forms the entire agreement between You and the Company regarding the use of the Application.
- **"Company"** (referred to as either "the Company", "We", "Us" or "Our" in this Agreement) refers to S2 Genomics, Inc.
- **"Content"** refers to content such as text, images, or other information that can be posted, uploaded, linked to or otherwise made available by You, regardless of the form of that content.
- **"Country"** refers to: the United States of America
- **"Device"** means any device that can access or run the Application such as a computer or a digital tablet.
- **"Third-Party Services"** means any services or content (including data, information, applications, and other products services) provided by a third-party that may be displayed, included or made available by the Application.
- **"You"** means the individual accessing or using the Application or the company, or other legal entity on behalf of which such individual is accessing or using the Application, as applicable.

### Scope of License

## Term and Termination
